

Frequently Asked Questions IIBA 20% Exam Rebate Promotion

1. What is IIBA's exam rebate promotion?

Starting November 1, 2025, at 12:00 AM ET to December 30, 2025, at 11:59 PM ET, IIBA is offering a 20% rebate on all certification exams: <u>ECBA</u>, <u>CCBA</u>, <u>CBAP</u>, <u>IIBA-AAC</u>, <u>IIBA-CBDA</u>, IIBA-CCA, and IIBA-CPOA.

To qualify, you must purchase your exam between November 1 and December 28, 2025, and complete the exam by December 30, 2025, at 11:59 PM ET.

2. Who is eligible?

The 20% exam rebate offer is available to IIBA individual members and student members in good standing. Non-members can become eligible by purchasing an IIBA membership before buying and booking their exam. Please note that members of the Partner, Academic, and Training Partner Programs are not eligible for this offer.

3. Do I need a special code to apply?

No. The rebate automatically applies to eligible members who purchase and complete an exam within the promotional period.

4. What does the rebate cover?

The rebate applies to exam fees and exam rewrite fees only. It does not cover application fees for the CCBA or CBAP. It is non-transferable, not redeemable for cash or credit, and subject to exclusions.

5. Do I need to complete my exam by the promotion deadline?

Yes. To qualify, you must purchase your exam between November 1 and December 28, 2025, and complete the exam between November 1 and December 30, 2025, at 11:59 PM ET.

6. Are all payment methods acceptable?

No. Only purchases made with a credit card are eligible for the rebate.

6. When will I receive the rebate, and how will it be processed?



Rebates are refunded to the original credit card used for payment, in USD, after the exam is completed. Processing may take up to January 15, 2026.

7. Why might the refunded amount differ from the original payment?

Rebates are processed in USD, and currency exchange rates fluctuate daily, so the refunded amount may differ slightly from your original purchase price in local currency.

8. Does the rebate apply to bundled pricing for exams?

Yes. For the IIBA-CCA, IIBA-CPOA, and ECBA bundles, the rebate applies only to the exam portion of the bundle price. For the ECBA, this means a \$39 rebate on the exam and a \$19 rebate on the exam rewrite.

9. Can I use this promotion for bulk exam purchases?

No. This offer does not apply to bulk or volume purchases.

10. Can I take the exam on the same day I purchase it?

No. Exams cannot be taken on the same day they are purchased. The exam fulfillment provider determines scheduling availability. We recommend booking your exam early to secure your preferred date and time.

11. Can this promotion be combined with other IIBA offers?

No. This rebate cannot be combined with other promotional codes, discounts, or offers. It is non-transferable, not redeemable for cash or credit, and subject to change without notice. In addition, certain exclusions may apply.

12. What happens if I need to cancel or reschedule my exam?

If you cancel or reschedule your exam after purchase, the rebate will only apply if the exam is completed by December 30, 2025. Check the rescheduling policies in the candidate FAQs on the <u>exam information</u> webpage.

13. What happens if I don't pass my exam?

If you need to rewrite the exam, the rebate also applies to exam rewrite fees, provided the rewrite is purchased and written during the promotional period.
